Key Background:

Market Expansion: In July 2024, the Korean government extended this FX trading window until 2 a.m., aligning with London trading hours. This expansion attracted 29 additional foreign institutions to join the Korean FX interbank market, enabling these FIS to offer spot transactions, FX swaps, and FX services for non-residents.

Policy Changes: Until recently, only 56 domestic financial institutions were authorized by the Korean government to trade the WON directly with USD and CNY. These trades were limited to a 6.5-hour daily trading window.
